COPYRIGHT POLICY: The Handwriting Clinic sponsors workshops that respect the ownership of materials and ideas by those who have developed them. It is fine to discuss someone else's ideas or work, as long as the slide and an accompanying bibliography states the authorship of the idea. If slides have pictures of clients or patients, the legal guardian or the adult in the picture must sign a release of information form. The signed release must state that the picture may be used for inservice presentations.

The following will assure compliance with the copyright policy:

All material must include references if it is someone else's published in a journal or peer reviewed magazine. A bibliography should be attached with references. The bibliography can be a separate handout for the participants, or it may be included as a slide in a power point.

All PowerPoint slides and subsections of handouts require references or a bibliography for material, ideas that are not your own.

Signed permission releases must be secured for all pictures, slides or handouts or other specific works (see definition below) used in the presentation that is not the presenter's own work.

No material may be photocopied or used as ones own idea if it is copyrighted without written permission from the author.

Presenter must provide written permission to use copyrighted pictures or works and inform attendees if there is a use of a picture or works within the presentation that is not ones own. Presenter must give credit to the owner of the copyrighted materials in the inservice slides and by verbal acknowledgement.

Speaker must not disclose any proprietary material from The Handwriting Clinic or his or her own facility that would be in conflict of interest to share.

COPYRIGHT DEFINITIONS:

Specific works: may include sound media, video, logo, photo, copyrighted publications, proprietary information, copyrighted books, other speaker's handouts or slide presentations or patents.

Disclosure and ownership of copyrighted works: Workshop presenter must clearly disclose any use of author's ownership of any idea, product, sound media, photo, etc. used within the presentation.

Proprietary Information: This can be proprietary information about an employer, service delivery, intervention specific to a work facility, etc.

Copyright release form:

In consideration of any action taken by The Handwriting Clinic in reviewing and editing, and the possible publication of an inservice, entitled:

The author of the presentation represents that he or she is the sole creator and proprietor of information included within an inservice presentation, and that he or she does not infringe upon any copyright or proprietary rights of others considered for publication by any other entity. The author agrees to obtain any required consents or releases of any other publisher or other person owning the rights of copyright of any **part** of the continuing education activity, including tables, charts, photographs, handouts, videos or ideas. In the event that the author does not have exclusive rights to the article and/or copyright The Handwriting Clinic shall have the right to terminate the contract for a sponsored inservice.
